<p><b>Benefit:</b> Free use of durable medical equipment for all current DPS employees, DPS retirees, and immediate family members.</p>	<p><b>Benefit:</b> Supplemental sick pay of \$50/day for days missed from work at DPS due to personal illness or injury, funded by monthly payroll deduction of \$10 per month.</p>
<p><b>Requirements:</b> No membership or fee required. Must be a current DPS employee, retired DPS employee, or an immediate family member.</p>	<p><b>Requirements:</b> Membership required. Join by requesting monthly payroll deduction. Must be a current, full-time DPS employee. See your building VPPP representative or call our office.</p>

You are eligible for the services provided by the Assistance Fund simply by being an active or retired employee of the Denver Public Schools. Medical equipment use has no time limit. We advise keeping the equipment until the family member using it is comfortable without it. You may borrow equipment for your own personal use or for use by any member of your immediate family. The funds used to purchase the medical equipment come from donations and memorials received from you, your relatives, and your friends and colleagues within and outside the DPS community.

### A Message from the President of the Board

I would like to welcome you all back to school. I hope that you had a restful summer and that the upcoming school year goes well for each of you.

Active employees of DPS, we need your help in recruiting new members in our Voluntary Payroll Protection Plan. More and more, older members are retiring. When that happens our membership drops. Please get the word out to new teachers that we are here to serve them. With membership in the Voluntary Payroll Protection you can receive supplemental sick pay of \$50/day for sick days used for your own illness. In your sixth year in the plan, you become fully vested for full benefits that would pay you for up to 100 sick days per year. Membership fees are only \$10.00 a month. If you needed to make a claim that first year you would get back more than what you invested.

If you are a building representative please check in with teachers and staff that are new to your school. If you need literature to pass out feel free to call the office at 303-377-0222 and we will be happy to get some to you. Our Assistance Fund offers the use of durable medical equipment to you and your immediate family. You do not have to be a member of the VPPP to use our equipment.

This could be due to your email deciding the attachment is too large, and therefore classifying it as 'Junk' automatically, not letting it through to your In-Box. Please add our domains - **dpssbp.org** and **qwestoffice.net** - to your 'safe' sender list, or select the option 'Never Block Sender's Domain' in your Junk-Mail folder in your email account if you find one of our emails there. You can also 'whitelist' our domain(s) through your email provider so that it will always be allowed through to your In-Box. Simply call the provider and say you want to 'whitelist' our domains and they will help you do so or do it for you.

## JOIN THE PAYROLL PROTECTION PLAN

**OPEN ENROLLMENT FOR 2016-2017 IS NOW UNDERWAY**

**Offered through the Supplemental Benefits Program to current full-time, salaried DPS employees**

As a full-time employee of the Denver Public Schools and a member of the **Payroll Protection Plan**, if you need extra cash to cover normal expenses while you are ill, the extra income provided by the **Plan** can make things easier for you. In addition to teachers, facility managers, lunchroom managers, office and administrative employees may join the Plan, as well. The Plan pays benefits of \$50.00 per day after you use the sick days provided to you by the district. Benefits increase in 5-day increments:

<b>1<sup>st</sup> Year</b>	<b>5 days</b>	<b>\$250</b>
<b>2<sup>nd</sup> Year</b>	<b>10 days</b>	<b>\$500</b>
<b>3<sup>rd</sup> Year</b>	<b>15 days</b>	<b>\$750</b>
<b>4<sup>th</sup> Year</b>	<b>20 days</b>	<b>\$1,000</b>
<b>5<sup>th</sup> Year</b>	<b>25 days</b>	<b>\$1,250</b>
<b>6<sup>th</sup> Year (Vested)</b>	<b>100 days</b>	<b>\$5,000</b>

Your premiums are payable monthly through payroll deductions. Cost is \$10 per month, or \$120 per year. Call our office or see your school site representative listed below.
